Boarding rates are \$44 for one dog, \$28 for the second dog and \$22 each additional dog in the same run. There is a \$50 charge for non-cancelation or not showing up for your reservation (no show, no call). Rates are subject to change. Rates are a maximum 24-hour period with a 2-hour grace period.					
Any dogs found to have fleas will be bathed and given a flea treatment at the owner's expense.					
There is a \$25 off hours convenience charge. Every hour at the kennel is choreographed for things to run smoothly, dropping off or picking up late or early could limit our productivity, hence the charge.					
There is a \$40 check return fee. We may refuse to take checks from you in the future if there is an issue.					
There is a charge for dispensing medication, depending on application.					
State regulations require that all food must be stored in sealed bags or airtight containers with lids. Not complying will result in a charge.					
Any food that requires special or extensive preparation (ex: raw diets, multiple ingredients, etc.) may result in an additional charge.					
A dog that compromises the safety of an employee or another dog, may be put into isolation, resulting in a potential charge.					
All dogs must be leashed until handed over to kennel staff. Out of courtesy to other patrons and liability of off leash dogs. DHR holds no responsibility for dogs before they are handed over to us or once we have returned them to the owner or owner's agent.

If Dog Holiday Resort is found liable for any kind of negligence we will only be held liable for a maximum of one hundred dollars in damage no matter what the circumstances are, including being found liable in a court o law. This contract also will cover future rate changes and changes to routines or otherwise by Dog Holiday Resort without further notice.
